**Notice of Race**  
*Emerald Cup 2004*  
**June 26-27**  
**Fern Ridge Lake – Eugene, Oregon**

**Rules:** The regatta will be governed by the Racing Rules of Sailing 2001-2004, and the US Sailing Prescriptions, except as any of these may be altered by the Sailing Instructions or class rules that do not conflict with the Rules, Prescriptions, or Sailing Instructions.

**Eligibility:** The regatta is open to all one-design classes, PHRF and Portsmouth fleets. Five (5) boats will be required to constitute a fleet, which may qualify for a separate start as determined by the race committee.

**Saturday, June 26**

9:00 AM - 11:30 AM Check-in / Final Registration at Lane County's Richardson Park Marina  
12:00 PM Skipper's Meeting, Richardson Marina  
1:00 PM First Start On the water  
Post-racing Dinner and Raffle, Richardson Marina

**Sunday, June 27**

11:00 AM On call for 1st start on the water  
Post-racing Awards Ceremony – Amphitheatre, Richardson Marina

**Format:** As many races as conditions allow will be scheduled – A variety of windward/leeward courses are planned. A minimum of 3 races required to constitute a regatta. Scheduled starting times may be delayed at the discretion of the Race Committee until suitable weather conditions exist.

**Trophies:** Trophies will be awarded post-regatta according to the number of boats in each fleet. In addition, there will be special recognition of the leader of each fleet after the first day's racing.

**Emerald Cup Award:** Each fleet shall select, at the skipper's meeting, a fleet representative. This person shall present, post-regatta, to the Emerald Cup Committee that fleet's nominee to receive the Emerald Cup.

**Camping and Moorage:** Richardson Park Campground, adjacent to the marina, is within the Lane County Parks system. Camping and RV sites are available by reservation and fill quickly. For camping reservations and marina information call: 541-935-2005.
