Rules

The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
The Organizing Authority is Lido-14 Fleet 7.

Eligibility and Entry

The regatta is open to all female persons who have a Lido-14 available for their use in the regatta. Both skipper and crew must be female. Membership in the Lido-14 Class Association is not required. It is the intention of the Organizing Authority to welcome non-members as guests pursuant to Article IX Paragraph 10 of the Lido-14 Association By-Laws.

Schedule

Registration will remain open on Saturday, August 8, from 9:00 AM to 11:00 AM.

The Competitors' Meeting will take place on Saturday, August 8, at 11:00 AM.

The regatta will consist of 3 races. The scheduled time of the warning signal for the first race is 12:30 PM. Prizes will be awarded as soon as possible after the last race.

Sailing Instructions

The Sailing Instructions will be available at the Competitors' Meeting.

Venue

All races will be sailed in the Sail Bay area of Mission Bay.

Courses

The courses to be sailed will be defined in the Sailing Instructions.

Scoring

One race is required to be completed to constitute a series.

A boat's series score will be the total of her race scores. This changes RRSA2.

Prizes

Prizes will be awarded for the first three places. In addition, the Dolores Lesnick Perpetual Trophy will be awarded to the first place skipper/crew team.
